By signing this form, I acknowledge I have read the terms and conditions, the code of conduct, the personal injury and equipment Insurance notice and terms of use for the cross country course, show jumping and Dressage arenas and understand that I use the course and/or show jumps and all/any facilities at Boroughbridge livery entirely at my own risk. I understand it is a condition of entry that no liability of any kind attaches itself to Sowray Livestock Ltd trading as Boroughbridge Livery or the landowners, and the landowners and any company attached accept **no** responsibility for any loss or damage to any person, animal, vehicle or property whatsoever - however caused.

I may fall off resulting in injury or death. I accept that risk.

I accept that riding a horse/jumping either cross country or show jumping is high risk and it is up to me to ensure that I and my horse have the ability to do so. The size of the cross country fences range from 50 cm to 1.1 meter and some are very wide.

I understand and accept that Boroughbridge Livery is a working farm and as such, I must be mindful of heavy machinery and vehicles.

Owners/riders / visitors enter entirely at their own risk and it is a condition of entry that no liability of any kind attaches itself to the organisers, landowner or any company attached in any respect whatsoever.

# Terms and Conditions

## IMPORTANT: FLU VACINATIONS

Equine Influenza is currently spreading through North Yorkshire. To safeguard our yard from any outbreak, we will be implementing the following procedures immediately to protect all horses visiting our facilities and our Liveries.

We kindly ask all those visiting our yard to:

- 1 Ensure all horses vaccinations are up to date .
- 2 Ensure you travel with your horse's passport. Please present your passport to the office or a member of staff prior to unloading.
2. Any un-vaccinated horses or horses without passports will be asked to leave immediately and refunds will not be given.
3. When walking through the yard to gain access to the facilities:
  - Do not hand graze anywhere on the yard or its facilities.
  - Do not allow any direct contact with any horses in fields or stables (visiting horses/riders/foot visitors)
  - No access is permitted **at any time** to our stable yards. Please keep to the track when riding to and from the facilities.

## IMPORTANT NOTICE TO ALL RIDERS

Before setting out on your ride, all riders/persons on foot must note the following terms and conditions for the use of this course.

Permission has been granted for you to use our cross country course, show jumping or dressage arena once you have signed the disclaimer on the understanding that you have read and acknowledge that the code of conduct, Terms of Course use & Personal Injury and Equipment Insurance Notice apply to your use of the course and arenas.

Failure to comply with the Code of Conduct when using our facilities could result in your future use being refused.

# Arena Code of Conduct - Show Jumping and Dressage

1. All persons entering the arena acknowledge and accept that they are riding or working horses, ridden or in hand entirely at their own risk.
2. All persons under the age of 16 must be accompanied by an adult who takes full responsibility for the conduct and safety of the child when in the arena.
3. Maximum horses - For safety reasons and workability, a maximum of 2 horses in the dressage arena and 4 horses in the show jumping area at any time. It is advised that one horse jumps at a time.
4. Safety hats, conforming to current regulations and appropriate footwear must be worn when riding, lunging or working horses in hand.
5. Body protectors conforming to current safety regulations must be worn when jumping.
6. Please do not use the arena's before your allotted time and please leave in a timely manner when your session has expired.
7. No turnout is permitted in this area.
8. All riders must carry a mobile phone in case of an emergency if they are riding on their own.
9. Racing is forbidden.
10. Riders or any person entering must report any accident, damage, rabbit holes, or loss of shoes to Rachael/Jess before leaving.
11. Smoking is strictly forbidden anywhere at Boroughbridge Livery.
12. Keep a distance of 2 horse lengths between riders.
13. The show jumping area is open in full daylight hours. Please do not jump at dawn/dusk.
14. All breakages must be paid for.
15. If you are hiring the arenas - please do not allow your horses to touch horses that are on livery with us. Please keep a good distance from them at all times.

## Code of Conduct - Cross Country Course

1. All riders must be accompanied by an adult, either rider or on foot.
2. Hard hats and body protectors must be worn - to conform to current standards for cross country as per British Eventing.
3. Correct footwear is obligatory.
4. All riders or their adult companions must carry a mobile phone whilst on the course.
5. Please do not start the course until your allotted start time as other riders may still be on the course. Please finish the course in a timely manner when your session expires
6. If the show jumping arena is vacant, it may be used for warming up – please leave it as you found it.
7. Racing is forbidden.
8. Keep strictly to marked tracks and please respect the crops.
9. Spectators are permitted, at their own risk and are responsible for their own safety. If spectators/adult companions take dogs, they must be on a lead and under control at all times for safety. Please clear up after your dog.
10. Riders/persons on foot must report any accidents, damage, rabbit holes or loss of horseshoes to Rachael/Jess/ Office before leaving.
11. Smoking is strictly forbidden anywhere at Boroughbridge Livery.
12. Keep a minimum distance of 2 horse lengths between riders. Wherever possible riders must communicate with other riders and spectators.
13. Please keep a safe distance away from the river at the far side of the course. The river can flood, so please be careful on the approach.

# Terms of Cross Country Course/Show Jumping/Arena Use

1. All riders **must read/sign** a disclaimer before using the course and arenas.
2. All jumps on the course are optional and the rider can choose not to jump any or all of the fences.
3. All XC fences to be taken only in the direction of the course markers.
4. It is each rider's responsibility to make certain that they and their horse have the necessary level of ability and experience before attempting to jump each fence.
5. Riders should familiarise themselves beforehand with all jumps but in particular, any jump in which they have doubts as to their ability to complete safely.
6. For safety reasons, we do advise that single riders should be accompanied by either another rider or a person on foot on the cross country course.
7. Any spectator or person accompanying a rider must keep well clear of all jumps.
8. Any accident must be reported immediately (see Contact numbers below) and a record made in writing before departing
9. Smoking is strictly forbidden.
10. Keep a minimum distance of 2 horse lengths between riders.
11. It is the responsibility of the rider to assess ground conditions are suitable before setting off on the course or entering the show jumping arena.
12. Please leave the show jumps as you found them.
13. All breakages must be paid for.
  - 13.1 Your horse must not come into contact with any horses that are kept at Boroughbridge Livery. Please keep a distance at all times.
  - 13.2 We have a secure parking area immediately after the entrance on the left. Vehicles are parked at owners risk. Any damage to parked vehicles should be reported to the Office, Rachael or Jess.
14. Please sign in/out of the yard as you are passing the office.
15. Please follow the BLUE arrows, which will take you to the arena and the start of the cross country course.
